"Lease has been granted for 210 kms. area by Govt. of West Bengal in favour of M/S GEECL for CBM mining in 2008 which includes Dhangajore and Madhukunda blocks. There is no overlap issue regarding these blocks.

There is overlap of mining lease (for an area of 22.17 sq. kms.) of ECL and GEECL over six existing ECL mines namely Kalidaspur, Ghusick, Chinakuri, Narsamuda, Parbelia and Patmohana which ECL possesses by virtue of Coal Mines Nationalization Act.

M/S GEECL FILED WRIT PETITION IN THE HON'BLE DELHI HC IN 2010 TO RESTRAIN ECL FROM MINING ACTIVITIES IN THE OVERLAP AREA WHICH WAS DISPOSED OF IN 2015.

SLP filed by M/S GEECL in August 2018 against ECL has been dismissed by Hon'ble Supreme Court of India.

IN OCTOBER 2020, CIL WROTE LETTER TO UNDER SECRETARY, MOC IN REPLY TO HIS LETTER 17.07.2020 REGARDING GEECL OVERLAP ISSUES."

In Chirugora area, a total 21 boreholes were drilled at an inclination of 45°. In upper level the spacing between boreholes was 50 meter and deeper boreholes were spaced 150 meters apart. The vertical depth of the individual boreholes is 50m and below. Apart from that, widely spaced boreholes have also been drilled to find out the extension. <i>Total reserves at 5% cut off is 1.652mt (11.39% P2O5), at 10% cut off is 1.054mt (15.05% P2O5)</i> and at 20% cut off is 0.256mt (22.33% P2O5) (FS 1983 to 1986 by S. K. Basu, Geologist (Sr.), A Roy, Geologist (Jr.), N. N. Choudhury, Geologist (Jr.) & S. K. Bandopadhayaya, Geologist (Jr.), 1897.) In Purdha area, a total 12 borehole were drilled at an angle of -45° with bearing towards N30°E. Nine boreholes were drilled with their spacing varying from 50 to 60 m within a strike length of 300 m. Three boreholes were drilled at a spacing of 100m to trace the continuation of ore zone if any towards east (there is no continuity of the ore body). A total reserves of 0.89 M. tons (at 5% P2O5 cut off) and 0.43m. tons (at 10% P2O5 cut off) (FS 1991-92 & FS 1992-93 by Dr. S.K. Bose, Ashoke Mukhopadhyay and Tapan Kr. Ghosh). In Medinitanr area, two phases of exploration were carried out. During first phase, a total 938m was drilled in 48 vertical and shallow boreholes reaching to a maximum depth of 26m. During second phase of exploration, a total 6 inclined borehole were drilled over a strike length of 350m. A total reserve drilled over a strike length of 350m. A total reserve

		of 0.19mt with an average grade of 6.99% P2O5 (FS 1987-89 by S. K Basu). The above borehole data represent G2 level exploration as per the UNFC categorization. Hence, in Chirugora, Purdha and Medinitanr area G2 level exploration work has already been carried out by GSI. In Kutni area of Purulia district, WB, one G4 level exploration was carried out by SU: WBAN, GSI, ER during FS 2018-19. But no promising zone was found for advance level of exploration.
